USE OF FACILITIES, RULES AND REGULATIONS WILL BE AFFECTED DUE TO COVID-19

You agree to abide by the rules, regulations and privileges of membership outlined herein and posted throughout the Clubhouse. We reserve the right to take whatever action is deemed necessary to ensure that you or any guests of yours comply with such rules, regulations, and privileges. Please see the Clubhouse Etiquette Form to familiarize yourself with our policies. The Clubhouse reserves the right to change the rules and regulations from time to time to keep up to current standards. HOURS OF OPERATION - The scheduled hours of operation are as posted. Times will change at the discretion of LPG. The Clubhouse or sections of it may be closed for private events without notice. The Golf Course, Clubhouse and Court facilities will be open from May 1st until October 31st, 2022. These facilities will be closed from October 31st until April 30th, 2023.

PRIVATE EVENTS – The Club is available for private events, subject to and Covid-19 health regulations.

CLUB ETIQUETTE: Please read and observe the Club Etiquette section of this Agreement.

Membership is for the 2022 season and will terminate October 31st, 2022, or earlier if determined by weather conditions.

All members and guests are required to check-in at Clubhouse. Allow approximately 2 hours per 9 holes.

The Golf Course is in a private community of residences and all golfers are expected to be courteous and respectful of the surrounding homes. This includes not venturing onto adjacent properties to find lost golf balls, not discarding waste along the route, keeping volume of voices down, using designated washroom facilities, etc. Not observing these rules may result in discontinuance of golf privileges with no refund of membership fees.

Further Etiquette rules may be posted at the facilities or on the website and may be revised at any time.
